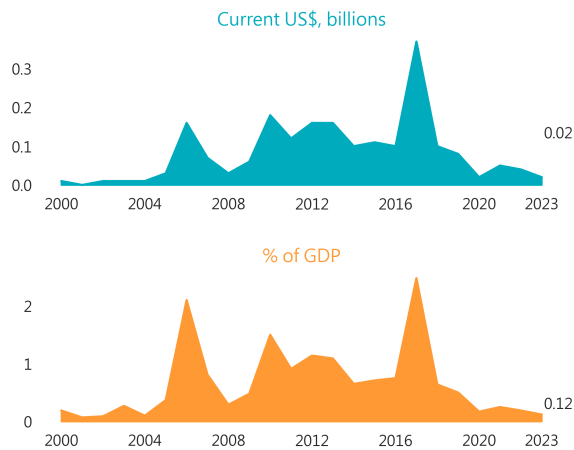

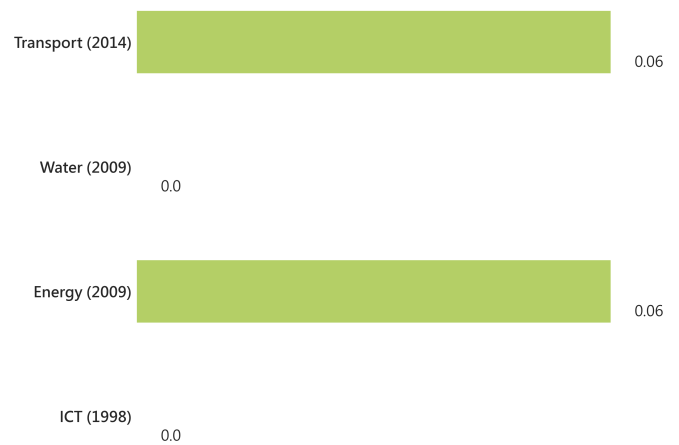

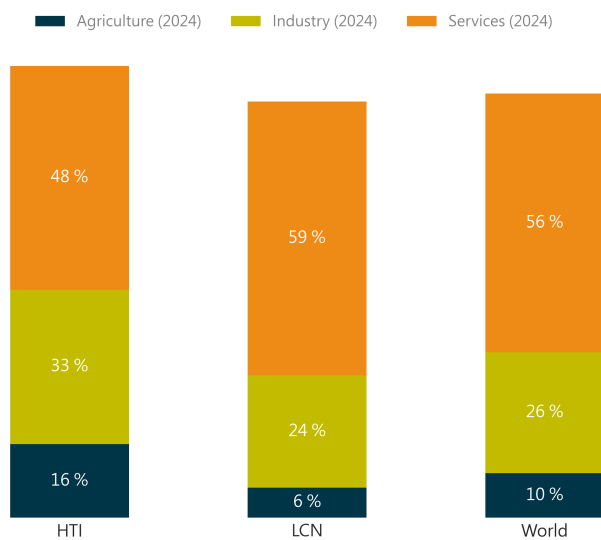
Inv. with private participation (USD, bn.)



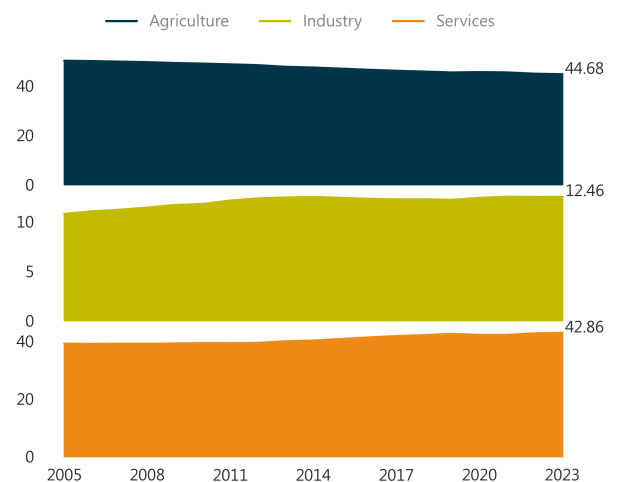
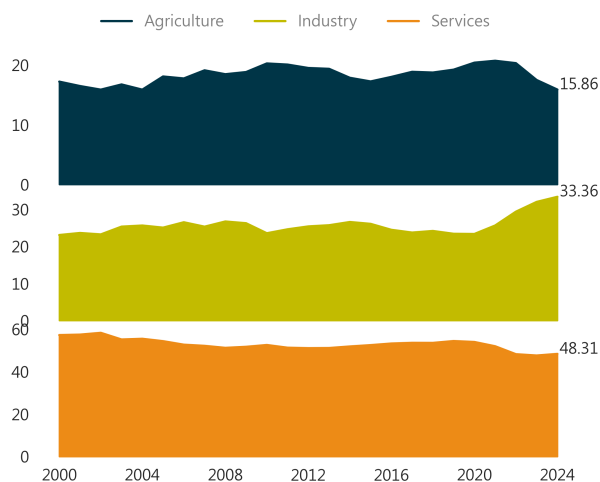
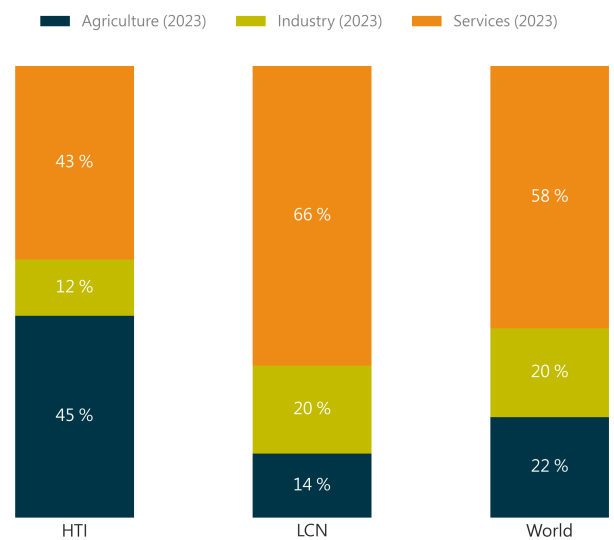

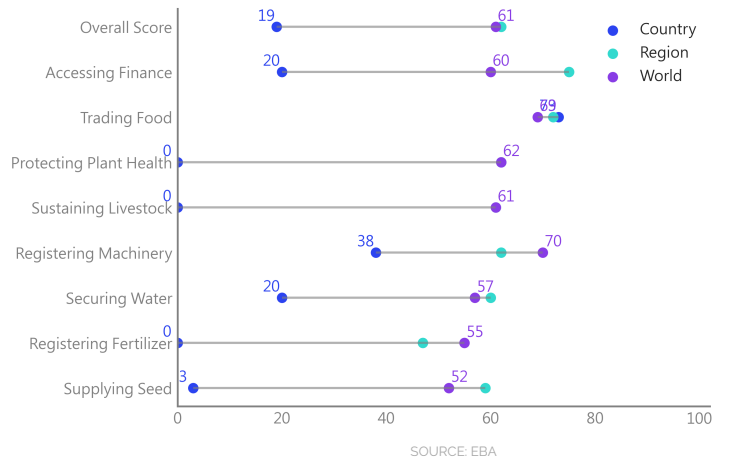

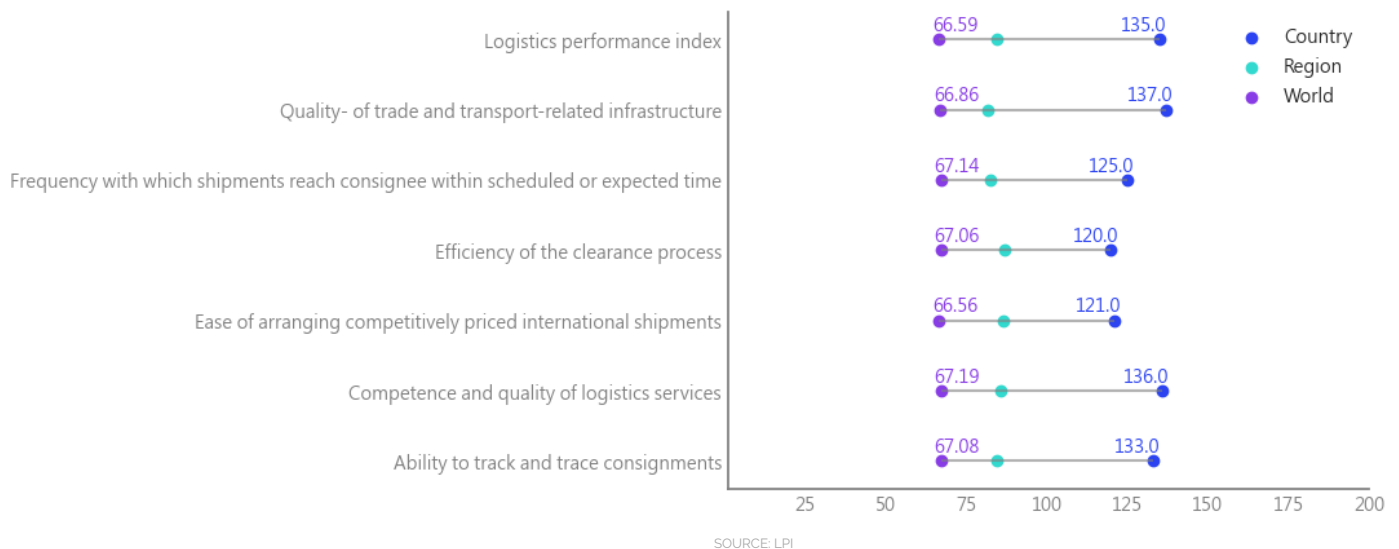
